Biography

Jeffrey K. Hadden, professor of sociology at the University of Virginia, was well known for his studies on religious broadcasters, the emergence of the Christian Right in the 1980s, and the comparative study of religion and politics. He was coauthor of *Prime Time Preachers: The Rising Power of Televangelism* (1981) and *Televangelism: Power and Politics on God's Frontier* (1988), as well as several works on politics, religion, and social change. Hadden worked closely with a number of religious groups such as the Unification and Scientology churches, sometimes acting as an expert witness in court cases. He died in 2003 at the age of 66.

Scope and Content of Collection

The collection contains files (correspondence, financial and tax records, clippings, notes, website printouts, brochures, newsletters, mailings and other promotional literature) assembled by Hadden, relating to various religious groups and leaders, mainly televangelists such as Jim Bakker (PTL), Jerry Falwell, and Pat Robertson.
