WARD EDUCATIONAL LEADERS MEETING

April 21, 1943

Meeting was called to order at 1:30 P.M. by Mr. Kitazumi in the absence of the Educational Director, Mr. Kawada. The following Ward Leaders were present: Messrs, Sakamoto, Kitazumi, Kajita, Fujimura, Ishino, and Nakai, a new representative from Ward VI.

Much of the discussion was concerning the coming Co-op Nite. The Ward II program will be held this coming Friday, April 23rd at 2920 Mess Hall from 7:30 P.M. Four posters for each block will be distributed by Mr. Kajita. It was agreed to have Mr. Sakamoto to speak that evening to acquaint the people with the work of the Educational Leaders. Mr. Kitazumi appointed Mr. Nakai as transportation chairman to be responsible for the transportation of all the talents who are to participate that night. Mr. Ishino will assist Mr. Hayashi with the door prizes for the evening.

It was decided upon that by using the mess hall lengthwise for the purpose would facilitate arrangements. Mr. Kitazumi asked all educational leaders to be at 2920 Mess Hall by 7:00 P.M. to make arrangements.

Due to another appointment, Mr. Fujimura asked to be excused early from the meeting. Before leaving, he was asked to contact Ward III for a mess hall for next week's program.

Beginning next week, the Co-op Nite will be held on Thursday nights instead of on Fridays so that the Recreation Dept. may have the P.A. system open for other purposes. It is also believed that by holding it on Thursday night a larger crowd would attend.

A discussion was held to have two Co-op programs going on at the same time. One program beginning at Ward I and another similar one at Ward VII. It was suggested by Mr. Kitazumi to have the directors from the Co-op office speak on their duties and responsibilities in their respective divisions. Further discussion will take place tomorrow. Tomorrow's meeting will be held at 708 from 1:30 P.M. Meeting adjourned for today.

WARD EDUCATIONAL LEADERS MEETING

April 26, 1943

The Ward Educational Leaders Meeting was called to order by Mr. Kawada at 10:00 A.M. at 708, instead of at 1:30 P.M. as formerly decided upon. Those in attendance were the following Ward Leaders: Messrs. Ishino, Sakamoto, Kitazumi, Hayashi, Nakai, and Fujimura of Wards I, II, IV, V, VI, and VII respectively.

The minutes of the previous meeting were read and approved by the members.

Mr. Fujimura was appointed representative from the Ward Educational Leaders to the Committee on Committees meeting. Mr. Hayashi will represent the group at the Auditing Committee meetings.

This week's Co-op Nite program will be held on Thursday, April 29th, so that the date will not conflict with the General Assembly Meeting to be held on Friday. It was decided, that hereafter, the Co-op Nite will be moved up to Wednesday nights.

Mr. Kitazumi asked for criticisms on the last two programs. The members all agreed that the program was quite successful.

Mr. Ishino asked to be excused. Before leaving, Mr. Kitazumi asked him to take over the distribution of the poster but Mr. Sakamoto volunteered to take it over.

The following suggestions were made to improve the Co-op Nite program:

1. Not to limit invitations to these programs but instead, encourage everyone to attend.
2. To change the headlines each time in the Tulean Dispatch when publicizing the program.
3. To have the choice of the chairman for the second part of the program left up to the respective Ward Leaders.
4. To give out better refreshments to the entertainers.
5. To donate \$5 or \$10 or whatever sum decided upon for the use of the P.A. system after the completion of all the programs.

Mr. Nakai and Mr. Fujimura were appointed to be responsible for general arrangements for the coming Ward III program. Mr. Kitazumi asked them to look into the following:

1. Reservation of an appropriate mess hall which

is centrally located in Ward III.

2. To notify Messrs. Honda, Elberson, and Kawasaki as to the date, place and time of the program.

It was suggested to ask Mr. Izuno to help pick out a mess hall and also to have him act as emcee for the evening.

Mr. Hayashi was asked to contact Mr. Sasaki, of the Recreation Department to get the talents for the program. Also to have a tentative program made out by 10:00 A.M. Tuesday to be given to the secretary to be typed and given to Mr. Honda and the emcee.

After some discussion, it was decided to have the Secretary send out individual thank you letters to each of the participants and emcees who took part in the Co-op Nite program. The secretary was also asked to write a letter to Roy Nikaido asking him to be emcee again this Thursday for the second part of the Ward III program.

Tomorrow's meeting will be held at 708 at 9:00 A.M.

As there was no further business for today, the meeting was adjourned at 11:00 A.M.

WARD EDUCATIONAL LEADERS MEETING

April 28 1943

A special Meeting of the Ward Educational Leaders was called to order by Mr. Kawada at 9:00 A.M. at 708. Those in attendance were the following: Messrs. Kawada, Nakai, Sakamoto, Hayashi, Ishino, and Kitazumi.

The minutes of the last meeting were read and approved as presented.

Mr. McNeil, a representative from Washington D.C. who is studying cooperatives in the various WRA centers was introduced to the group. A round table discussion was held with questions directed to Mr. McNeil.

Questions asked were as follows:

Mr. Sakamoto: In what way could we educate the people on the cooperative movement?

Mr. McNeil's suggestions were as follows:

1. Introduce study clubs--with general psychology of cooperatives, public speaking, newspaper articles. The main thing to make the classes interesting as possible.
2. Speakers--speaking on general education.
3. Visual education--very important to public.
4. Cooperative plays.
5. Recreation.
6. Credit unions.
7. Library idea--to have supplementary literature.
8. Bulletin boards--for informations on cooperatives.

Mr. Nakai asked about the Co-op Movement in Amache, Colorado. To this, Mr. McNeil stated he did not know about this particular movement but thought it would be a splendid idea to introduce Co-op in the local schools here for the educational value of the children. He suggested cooperative games could be introduced in the schools by the educational leaders. Another point he also stressed was to keep alive the knowledge of cooperatives in the people after it has once been introduced.

When asked what improvement would be made on the cooperative movement here, Mr. McNeil suggested to have more publicity.

Mr. Kitazumi explained to Mr. McNeil that the purpose of the Educational Leaders was merely to be organizers to plan ways of introducing cooperative to the public.

Since Mr. McNeil thought he would be here at least another week, the group asked him to meet with them once more so they could gain more by his helpful suggestions.

A lengthy discussion took place on the subject of the Visual Educational Program. Mr. Kitazumi, after speaking with Dr. Francis, reported she was very much in favor of the idea. Also, Mr. McNeil strongly stressed the importance of it stating that up-to-date newsreel and good pictures on cooperatives was one way of approaching the public. Finally, after much deliberation a motion was made, seconded, and carried that the Educational Leaders request the Board of Directors for its approval on the Visual Educational Program. In the meantime, the leaders could be looking into the matter of place and date reservation, expense and other minute details. Before any further discussion, the matter will have to be tabled until it gets the approval of the Board of Directors first.

Suggestion was made to have Mr. Sakamoto take the matter up with the Management Committee and report back on its decision.

The secretary was asked to type out a weekly report to Dr. Francis concerning the work and activities of the Educational Leaders during the past week.

Mr. Kawasaki asked Mr. Kawada to make a talk on the work of the Education Committee at the Ward Assembly Meeting to be held Friday night at 1620.

Meeting adjourned at 11:15 A.M.

WARD EDUCATIONAL LEADERS MEETING

May 3, 1943

The meeting was called to order at 9:10 A.M. at the Kitazumi home by Mr. Kitazumi. The following Ward Leaders were in attendance: Messrs. Nakai, Hayashi, Sakamoto, Ishino, Fujimura, and Kitazumi. Also present was the Director, Mr. Kawada.

The minutes of the previous meeting were read and approved. The following correction was made on April 28th minutes. The second from the end paragraph on the first page should read as follows--Mr. Kitazumi explained to Mr. McNeil that the purpose of the Educational Leaders was primarily to be organizers to plan ways of introducing cooperative to the public.

A report on the coming Ward IV Co-op Nite program was given by Mr. Kitazumi. Mess Hall 1120 has been chosen as the most suitable location in Ward IV for the program to be held this week. The posters will be distributed today and the requisitions for the mess hall has already been made. Mr. Katagiri, Ward IV Chairman has been selected as emcee for the first part of the program. Mr. Katagiri and Mr. Kitazumi have contacted Mr. Kawasaki of the Executive Board as to the change of date. The Ward Assembly Meeting scheduled for Thursday has been postponed so that our Co-op Nite program could be held on that night, May 5th from 7:30 P.M. Hereafter, the Ward Assembly for the respective wards concerned by the Co-op Nite program will be postponed for the convenience of the leader assigned to the meeting.

A suggestion was made to extend the program two weeks longer so that the Caucasian staff and the Base Hospital patients could be included in our tour. A motion was made, seconded, and unanimously passed to that effect.

Mr. Hayashi gave a report on the entertainments. Most of the talents have been lined up but the list has not been completed as yet. He hopes to have it completed by the end of the day.

It was reported that Mr. Honda will put the first publicity in the Tulean Dispatch today stating the time, place and date of the coming program. He will strongly emphasize the ten doorprizes to be given out that night.

The secretary was asked to send copies of the program to Mr. Katagiri and Mr. Roy Nikaido, chairman for the first and second part of the program respectively. Hereafter, Mr. Nikaido will always be the emcee for the second part of the coming programs.

Our decision will depend entirely on the information he has to give us.

A weekly report should go into Dr. Francis every Monday. Up to the present, Mr. Kitazumi had been making the weekly reports but hereafter he thought that Mr. Kawada should do so since he was the director.

Mr. Kawada also reported on the Essay Contest Plans.

WARD EDUCATIONAL LEADERS MEETING

May 4, 1943

The meeting was called to order at 9:15 AM. at 708 by Mr. Kawada. Those present at the meeting were the following Educational Leaders: Messrs. Hayashi, Nakai, Ishino, Sakamoto, Kitazumi and Fujimura.

The minutes of the previous meeting were read and approved as presented by the secretary.

Mr. Kawada, chairman, gave a report on the essay contest. Prizes for the winners will be \$2.50, \$1.50, \$1.00 in book orders to the first, second, and third place winners respectively. A Co-op emblem pin will be the consolation prize for the next five or ten winners as decided by the group. To create more interest among the students, it was suggested to publicize the contest at the high school. The contest will continue for two weeks. Mr. Kawada was asked to contact Mr. Ikeda to get him to be one of the judges for the contest. He has been recommended as a very capable person. If, for any reason he will be unable to do so, Dr. Ichihashi will be contacted. Topics chosen are as follows:

1. What the Co-op Means to Me.
2. Cooperative as an Aid to Relocation.
3. Co-op in Post War Reconstruction.
4. Future of Co-op.
5. Co-op in Relation to World Peace.
6. How to Improve the Co-op here.
7. Value of Co-op in our Community.
8. Philosophy of Cooperation.
9. Co-op Versus State Socialism.
10. Why Cooperative Education is Essential to Sound Development.

Suggestions were made to have poster division in our Co-op staff and to consult with Board of Directors about the idea, also to have the library stock up on Co-op literature and pamphlets. The Research Director will be asked to investigate into further details of these pamphlets.

Mr. Kawada reported that he took the matter of Visual Education up with the Board of Directors. The Board of Directors have given full authority to the Educational Leaders to proceed with the plans of the Visual Education Program. The only request they made was to keep the cost of expense within 1% of the net Co-op profits.

Due to a previous appointment, Mr. McNeil was unable to speak to the group today.

Although it was agreed yesterday that Mr. Kawada would make the weekly activities report to Dr. Francis, it was decided today that it would be better if Mr. Kitazumi resumed this responsibility as before.

The meeting was adjourned at 10:30 A.M.

No date has been set as yet.

A report was given by Mr. Kawada concerning the posters. He has contacted Warehouse 351 and according to them, there is a poster department there but the person in charge of it is ill at present so could not be contacted. Although the posters publicizing the Co-op Nite program cost 15¢ apiece the leaders agreed it would be better to get new one for each ward.

A suggestion was made to have the Co-op stock up on more posters similar to those tacked up in the Co-op office now. It is believed that posters are one way of acquainting the public with the cooperative movements.

A letter from Heart Mountain WRA center was read by Mr. Kawada. They want information on the business we have here and the number of workers employed so they can compare themselves with us in this line.

It was agreed by the members to have the director order 50 Co-op emblem pins to be given as consolation prizes for the essay contest and also to be distributed to the Co-op staff. If found popular with the other Co-op employees, more will be ordered at a later date.

Since there was no further business, the meeting was turned over to Mr. McNeil who spoke to the group on "Fundamentals of Co-op".

Meeting was adjourned at 10:30 A.M.

WARD EDUCATIONAL LEADERS MEETING

May 6, 1943

The meeting of the Ward Educational Leaders was called to order at 9:20 A.M. by Mr. Kawada at 708. The following members were present: Messrs. Kitazumi, Nakai, Ishino, Sakamoto and Hayashi.

The minutes of the previous meeting were read and approved by the leaders as presented.

Mr. James Nakagawa, Research Director of the Co-op staff was present to give a report on the progress in his research work.

Fish Market: Since the need of a fish market seems very urgent to the colonists, negotiations have been made since February to build a fish market within the center. Plans are almost completed to build a temporary building 12'x16' in the fire-break between block 18 and 25 since that seems to be the most centralized location. Construction will possibly begin next week and will be completed within two weeks.

Tofu and Miso: Investigation have been made and raw materials will be available for making tofu and miso. The Morton Salt Company of Newark, California have also been contacted. Equipments will be available from an evacuee who formerly operated a tofu market prior to evacuation. Block 66 laundry room has been tentatively selected as the location for making it.

Newspaper: General information have been collected from Heart Mountain and Minidoka concerning the printing of their newspaper. Estimated cost for a 12"x18" newspaper, printed bi-weekly will be about \$99 for 4000 copies per issue. Negotiation are being made to send three proof readers to Tule Lake where it is to be printed. All this will be discussed at the Ward Assembly meeting.

Motion Picture: Plans are being drawn to have a theatre built here by the WRA with the lumber which was formerly intended for canteens. The building which is to be 120'x40' will be owned by the WRA and rented to the Co-op for approximately \$130 a month. The matter of films, movie projectors, estimated expense and other minute details have been carefully studied.

Suggestion was made to have Mr. Sugimoto, the Treasurer come tomorrow and give us a thorough financial report. Mr. Kawada will get in contact with him. Later we will have other directors of the Co-op staff come and give us their report.

Mr. Kitazumi was appointed to be a representative from our group to the employees class held every morning.

Plans for the Co-op Nite Program for tonight have been completed

However, the next week program will be on Friday, May 28th. Due to change of date, the 49 Mess Hall will not be available, therefore a new hall will be arranged for.

Letter from Mrs. Marion Francis on the work performance record for Merit Board Rating was read by Mr. Masao Kawada.

An outline of the contemplated program for the Educational Leaders to work upon was presented by the Educational Director. The main purpose of the program is to further the understanding of the people on Co-op matters and activities. To carry out this Ward Educational Leaders program, it was suggested that a question box be placed in the block managers' offices so that whatever questions the people may wish to ask about any phase of the Co-op activities can be properly answered for them by the Educational Leaders.

The average cost of presenting the Co-op Nite Program has been about \$15 (fifteen dollars) for each night, besides the cost of the posters.

Mr. Nakai and Mr. Ishino will contact persons for poster art work in the Poster Department of the Co-op.

Suggestion was made by Mr. Kitazumi that the Educational Leaders make a tour of the local Co-op warehouse, offices and stores to acquaint themselves with the work that is being carried out in various departments.

As there was no further business, the meeting was adjourned at 10:15 A.M.

Mr. Ed Kitazumi, the chairman opened the meeting and introduced the various persons present to meet the High School Committee.

These committee members were appointed by the Students Council of the Tri-State High School to investigate the establishment of a high school cooperative.

The request for this meeting was made by the committee from the Tri-State High School in order that they may learn how a cooperative store is established and to become more informed on the general principles of cooperatives.

Mr. MacNeil suggested to the group that they study to Co-ops thoroughly and then find out what article they wished to begin with. He stressed the fact that the start should be made on a small scale and gradually expanded as they become more familiar with the management of cooperative store.

Mr. T. Kawasaki, Executive Secretary explained the administrative functions of the officers of the Tule Lake Cooperative Enterprise. He suggested that the committee study and propose a definite plan to the Management Committee of the Tule Lake Cooperative Enterprise for their further study of the submitted plan.

The Educational Director also emphasized that they should study and submit a definite plan. He suggested to them to make use of the Co-op literatures which are available for study at the Co-op Circulating Library. Also that it would be a good idea for them to attend the Co-op Nite Programs and to contact the Ward Educational Leaders for information on various phases of Co-op activities in this community.

Mr. Kitazumi suggested that the committee members are invited to tour with them through the various canteens, offices, shops and warehouses if they so desire and with the approval of the High School officials.

WARD EDUCATIONAL LEADERS MEETING

May 20, 1943

The meeting was called to order at 9:45 A.M. by the Educational Director Mr. Kawada at 708, Merit Board Conference Room. The following Leaders were in attendance: Messrs. Sakamoto, Kitazumi, Nakai, Ishino, Hayashi and Fujimura. Also present was Mr. Don Elberson.

The minutes for the meeting of May 19th were read and approved as read. The following correction was made on May 18th minutes in the paragraph beginning "Suggestion was made by Mr. Kitazumi-----due credit be given to the person from whom the information originated" which now should read "-----due credit be given to the person or groups from whom the request for release is made".

The Educational Director read the interpretations of the Executive Committee which are as follows:

1. That the duties of the Educational Committee are to originate and formulate plans and policies on Educational work and which are to be recommended to the Board of Directors for approval.
2. That the Ward Educational Leaders are to carry out or execute the approved plans of the Educational Committee, and also be given the opportunity to make suggestions and recommendations to the Educational Committee.

The Executive Committee made the following recommendations to the Ward Leaders:

1. That the Ward Educational Leaders select a chairman out of their own group.
2. That the Educational Director act as an advisor and coordinator to the Educational Leaders.
3. That a request be made to Mrs. Marion Francis, Head of Adult Education to assign a secretary to the Ward Educational Leaders.

The following suggestions were made by the Leaders:

3. That the Leaders should be given the right to meet jointly with the Educational Committee to formulate educational plans.

Mr. Don Elbersen, Advisor to the Tule Lake Cooperative Enterprises, Inc. explained the administrative functions of the Educational Committee. He suggested to the Leaders that they draw up a definite outline of what they desire and present the request to The Committee on Committees for further study, also send one copy to the Board of Directors showing that such requests and plans were presented.

A suggestion was made by the Leaders that Mr. Elbersen be present at an arranged joint meeting of the Ward Educational Leaders and the Educational Committee to explain the functions of each group.

Mrs. Marion Francis informed Mr. Kawada that since the Educational Leaders are part of the Adult Education Program that the possibility of eliminating the Leaders from the payroll will not be likely. However, if the WRA changes the budget it may be necessary to cut down on the Adult Education personnel but at the present time is not definite.

A summary report on the Ward VI Co-op Nite program was given. All arrangements including the talent list are complete. Mr. Otsubo of Block 53 has been chosen to emcee the first part of the program. The second part will be turned over to Mr. Roy Nikaido as in previous weeks.

Mrs. Marion Francis will meet with the Leaders tomorrow, May 21st at 10:30 A.M.

There being no further business, the meeting was adjourned at 10:45 A.M.

EDUCATION COMMITTEE MEETING

May 21, 1943

The first meeting of the new Education Committee was called to order at 3:30 P.M. by the Educational Director, Mr. Masao Kawada, at 708, Merit Board Conference Room.

ROLL CALL

The new Education Committee members in attendance were the following: Messrs. Sachihiko Yamamoto, James Okamoto, S. Omura, Frank Nakamura, Keant Morimune, and Mrs. Y. Yoshida representing Wards II, III, IV, V, VI, & VII respectively. Also present were Messrs. Don Elberson, Advisor to the Tule Lake Cooperative Enterprises, Inc., Neil MacNeil, T. Kawasaki, Executive Secretary, and Teranishi, new Personnel Director.

Mr. Masayuki Horiuchi, who is to represent Ward I was not present.

WORK OF PAST EDUCATION COMMITTEE AND WARD LEADERS.

A written summary report on the work of the past Education Committee was distributed to the members to acquaint them with plans and programs which had been previously drawn up.

INTERPRETATION OF THE DUTIES.

Mr. Kawada read the interpretations of the Executive Committee which are as follows:

1. That the duties of the Education Committee are to originate and formulate plans and policies on Educational work which are to be recommended to the Board of Directors for approval.
2. That the duties of the Ward Educational Leaders are to carry out or execute the approved plans of the Education Committee and also be given the opportunity to make suggestions and recommendations to the Education Committee.

Mr. Kawada explained that the above interpretations were not favorable with the Ward Leaders since there would be a distinct division line drawn as to their respective duties. Since the Ward Leaders are familiar with the Educational program, they suggest it advisable to meet with the Education Committee and formulate the plans together. Mr. Elberson's opinion was the same, believing that co-ordination of both groups is vital to carry out the educational program successfully and that the formation of policies should be made together.

DISTINCTION BETWEEN EDUCATION COMMITTEE AND WARD EDUCATIONAL LEADERS.

Mr. Morimune stated since the Education Committee and the Ward Leaders are two entirely different bodies whose functioning duties are also different, there should be distinct division line drawn. Otherwise, he sees no necessity in having two groups with similar responsibilities. He believes the duty of the Education Committee is to represent the colonists and make recommendations and suggestions

to the Board of Directors what they desire while on the other hand, the Ward Leaders are to execute the approved plans.

SUGGESTIONS

The following suggestions were also made:

1. That the Education Committee meet twice a month, once by themselves for discussion and formulating plans. Then, the second meeting with the Ward Leaders to submit the plans to them for their opinion.
2. To select a chairman for the combined group.
3. To specifically distinguish the duties of the Education Committee and the Ward Educational Leaders in the Co-op By-Laws. Until such a time the By-Laws can be altered, which will possibly be in June when the General Assembly meets, the program will be carried on as before with the understanding of both groups.
4. To make a general report on the past activities of the Ward Leaders and distribute to the Education Committee members.
5. To have the secretary send out an agenda with the meeting notices.

The definite conclusions made at the meeting and accepted favorably by all were:

1. That the Education Committee and the Ward Leaders meet jointly to discuss plans and policies with the provision that the final deciding power to make recommendations to the Board of Directors be placed with the Education Committee.
2. That the Education Committee members, after meeting 2 or 3 times or until such a time they become acquainted with one another, will select a chairman from their own group.

The next meeting will be held jointly with the Ward Leaders.

As there was no further business, the meeting was adjourned at 4:45 P.M.

WARD EDUCATIONAL LEADERS MEETING

May 24, 1943

The meeting was called to order at 9:45 A.M. by the Educational Director Mr. Kawada at the home of Mr. Kitazumi. The following Leaders were in attendance: Messrs. Nakai, Kitazumi, Hayashi, Fujimura and Isamu Shijo who is to replace Mr. Sakamoto of Ward II when he leaves.

As the minutes of the previous meeting were not ready, they were not distributed to the members.

Mr. Isamu Shijo was introduced to the Leaders.

Mr. Hayashi reported on the coming Ward VII Co-op Nite Program. The date has been postponed to Friday, May 28th since the P.A. system will not be available for Thursday evening. It will be held at the usual time from 7:30 P.M. at 7018 Mess Hall. Mr. Fujimura is making the requisition for the mess hall and the P.A. system and also taking care of the distribution of the posters in each block. Mr. Fujimura who spoke in behalf of the Educational Leaders at the last Ward VI program introduced the block representative to the Co-op. It was generally agreed that this is a very good idea. Since an appropriate person cannot be contacted to be chairman for the coming program, Mr. Fujimura will emcee the first part of the program and also speak in behalf of the Leaders.

It is quite obvious that the programs have made the colonists Co-op minded and it has definitely worked out a huge success. By these programs the public are realizing the true meaning of cooperatives.

WARD EDUCATIONAL LEADERS MEETING

May 25, 1943

The meeting was called to order at 9:30 A.M. by the Educational Director Mr. Kawada at 708. The following Leaders were in attendance: Messrs. Kitazumi, Fujimura, Ishino, Sakamoto, Hayashi, Shijo and Nakai.

The minutes of May 21st meeting were read and the following correction was made. The opinion expressed by Mrs. Francis was that all committees were on equal basis and no group had any more power over another, except the Board of Directors.

A report on the coming Ward VII Co-op Nite Program was given. Selection of a chairman for the first part of the program and the speaker will be left up with Mr. Fujimura. People from the ward will assist Mr. Ishino with the doorprize tickets to avoid duplication to any person. The program will be conducted in a similar manner to that of Ward VI.

For the Caucasian and Base Hospital program, it was suggested to have Mr. Kitazumi as the presiding chairman. Mr. Kawada, at these programs will speak on the activities of the Ward Leaders. Mr. Sakamoto and Mr. Ishino were appointed to contact Dr. Pedicord for permission to put on the program for the hospital patients. They were requested to report back the answers as soon as possible so arrangements can be made. Mr. Hayashi suggested that small gifts be distributed to each patient attending instead of having the usual doorprize drawings. Mr. Kawada was asked to consult the Board of Directors for their approval to this idea. Another suggestion was made to include a few Japanese numbers in the program.

Before putting on the program at the hospital, Mr. Fujimura suggested to first put on a Co-op Assembly at the High School. In this way it would create more interest among the students towards organizing the High School Co-op. Arrangements will be made as soon as Mr. Kitazumi and Mr. Nakai discuss it with the high school officials and get their consent.

Full particulars on the High School Co-op so far was given by Mr. Nakai. The Co-op will be organized possibly within this present school term and will be independent of the Tule Lake Co-op. One representative from each class are chosen and from this group, a committee of well qualified and persons interested in Co-op will be selected to aid the Leaders in carrying out the plan. A suggestion was made that it would be better if the High School Co-op would start on Credit Union rather than on cash basis.

Mr. Kawada informed the Leaders that according to Mrs. Francis, Bert Wilson, Associate Professor of Commerce at Humboldt State College, California will be available for this summer to hold classes for persons interested in studying human relations, leadership training, cooperative bookkeeping and in any other field the people may have interest.

"WHY WE SHOULD CARRY ON AN EDUCATIONAL PROGRAM?"

A discussion of the importance of an Educational Program took place. Don Elbersen, advisor was asked to give his opinion on "Why We Should Carry on an Educational Program?" He stressed the importance of the educational phase of cooperatives.

1st reason---importance in relocation. Cooperatives as a means of assimilation of the people by racial equality. Upon relocation, the Japanese people should identify themselves with the liberal thinking people and in this way be accepted into the American society. One barrier which must be overcome in regard to assimilation is the individualistic ideas the Japanese generally have. He also stated that the WRA is trying its best to work out a plan so the Japanese can become a part of the American life in the outside world.

2nd reason---importance in post-war. Concentration of economic power in both the political and business fields.

NEIL MACNEIL AS HONORARY MEMBER OF THE EDUCATION COMMITTEE

A suggestion was made by Mr. Kitazumi to have Mr. Neil MacNeil as an honorary member of the Education Committee and to have his work coordinate with that of the Educational Director. The suggestion was accepted as favorable by all.

Mr. Elbersen recommended Mr. MacNeil to the groups as being very capable on conducting the study and discussion groups which are being planned.

June 4, 1943

STUDY OF PRINCIPLES OF COOPERATIVE MOVEMENT

In regard to the Japanese discussion groups suggested by Mrs. Francis, Head of adult education, Mr. Morimune thought a study of the principles of cooperative movement at these groups may be one way in clearing any misunderstandings among the isseis. Another suggestion was made that possibly the church groups, block clubs, and the women's clubs could assist in conducting these groups.

Following a discussion as to the most convenient date for a meeting to discuss further plans for the educational program, it was moved that another joint meeting of the Education Committee and the Ward Educational Leaders be held on Tuesday, June 8, 1943 from 3:00 P.M. at 708, Merit Board Conference Room. The motion was duly seconded and unanimously carried.

The secretary was advised to send meeting notices two or three days prior to the meeting date.

Upon motion duly made, seconded and carried, the meeting was adjourned at 4:50 P.M.

PLANS FOR INTRODUCING COOPERATIVE MOVEMENT TO THE COLONISTS
BY MEANS OF DISCUSSION AND STUDY GROUPS.

The following suggestions were made:

— First: That the group discussion group should not be too large. At the most five or six persons would be about the number that ought to participate for the reason that if a large group were assembled, the discussion would be too unwieldy.

Second: That it would be well to start a discussion about co-operatives in the boiler room.

Third: That each Block Manager and the Block Representatives ought to be contacted and discussion begun with these group.

Fourth: Mr. MacNeil suggested that how we contact with the colonists is entirely up to us. There are two approaches; first, go into community and have a general meeting. Secondly, go in and contact with certain persons and deal from there.

It would be well to contact people that we know might be interested in co-operatives and organize with five or six people in the group, and then build from there. After a while people will become interested and the group will increase, and then it could be further divided into smaller groups. The start ought to be made with things that might appeal to the colonists; such as, relocation and agricultural work.

Fifth: Mr. Kitazumi stated that a contact should be made first and then proceed with definite plans. We should have plans all mapped up so that it could be followed out. Discussion of farmers co-operatives might be received quite favorably by the colonists since many people are resettling now. Immediate contact should be made with the colonists and find out what they want to discuss instead of the leaders telling them what ought to be the proper topic to talk about.

Conclusion: The responsibility of carrying out the discussion by group work in the project ought to be placed with the leaders. The following conclusions were finally agreed upon:

First: That Mr. Fujimura will approach the people in his Ward through the boiler room discussion.

Second: Mr. Shijo will conduct his discussions in the mess hall. He will contact the Block Manager and the Block Representatives and decide the future discussion group.

Third: Mr. Ishino will do likewise.

After further research work is conducted, the leaders will decide upon the kind of literature to obtain.

The next regular joint meeting of the Educational Committee and of Ward Educational Leaders will be held on June 22, 1943, from 3:00 p.m. at 708 Merit Board Conference Room.

Since there were no further business the meeting was adjourned at 4:20 p.m.

Slide projectors for educational uses were approved.


There was a suggestion that Co-op movies be shown together with the other Recreational Department movies. This was discussed and tabled for future study.

SAVINGS PLAN

Mr. Shinowara and Mr. Takagi, both former bankers, were invited by the Ward Educational Leaders to discuss about the savings plan with the Educational Committee. The Leaders explained that as the children are spending money thoughtlessly, it would be advisable to set up a savings plan whereby the children will learn the purpose of thrift and need for savings.

Mr. Shinowara stated that it would be better that Co-op did not handle this for the following reasons:

1. There is a state law governing if handled thru a Cooperative Enterprises, which will complicate management.
2. That Co-op must invest in loans or buy bonds to earn enough money to give interest on the savings.
3. Project wide savings plan would be inadvisable under the present conditions.

Mr. Shinowara and Mr. Takagi suggested that school savings plan will be the best for the school children as they have been doing this outside, and the parents might soon join in. If it is school savings, the leaders can consult with the teachers and get in touch with the bank. In this way matters will be done between school and the bank, and the procedure would be simple.

For the colonists over school age, Mr. Shinowara suggested making a group of one body or club and start a savings plan

The group will stand in between the depositors and the bank and receive the savings money, note it on the depositors' pass books, send the money to the bank and have the bank handle the books.

After much discussion it was decided that Mr. Shijo, Mr. Ishino, and Mr. Hayashi contact the teachers and ask them to give the children notes stating the intention of starting the school savings and the purpose of savings. This note is to be taken home for the parents' signatures if interested. This will be very essential to get the general idea of how many are interested. It was also suggested that the Leaders should get in touch with the PTA at the same time and get their opinions. Mr. Kawada stated that if the Educational Committee Members wanted to discuss about the savings plan further and in detail to get in touch with the Leaders so a definite plan can be worked out.

The discussion about the postal savings stamps was brought up, but this idea was dropped as this did not seem favorable.

Mr. Kawada reported that the Community Activities have three projectors going around the project and that the Co-op could have the Co-op picture shown in conjunction with theirs. By Mr. Harry Mayeda's suggestion Mr. Kawada will study their schedule of the showing so that the Leaders can put in the order for the films accordingly.

Mr. Kawada reported that cost of slide film projector will be about \$40.00. As soon as the price of the slide film is known the projector will be purchased. The Leaders and the Committee Members thought that the slide films will be very good, for it will show the principle of the Co-op which could be shown from one group to another to stir their interest in the Co-op.

Mr. Kawada stated that 801-C is being set up as patronage dividend stub receiving office.

Mr. Kawada reported that a letter of appreciation from Miss Manji, Advisor to the Tri-State High School Co-op Committee, for the tour conducted for them to the Business Office and Warehouse on Thursday, June 17, was received. Mr. Shijo gave a brief report on the above tour for the benefit of the Educational Committee Members.

The plain stamp book will, of course, have no reading matter on it whatsoever:

"The stamp books can be printed on a very attractive grayish blue paper. The stamps might be a buff color, similar to the attached.

"Delivery of stamps and books can be made in one week after receipt of order."

Action on the stamp books was tabled as suggestions for a pass book was taken up. Mr. Elberson and Mr. MacNeil said they would look into this matter with the Tule Lake Bank and with CUNA or a central office of the California Credit Unions.

The Leaders and the Committee Members will make further study on the contents of the Annual.

Educational Director reported that Mr. T. Hashida will be the Editor under the sponsorship of the Educational Dept.

Mrs. Van Buskirk is starting a discussion on Farm Co-operative at 717-A, Wednesday night, July 7, 1943, and Educational Director requested the Leaders to attend.

Mr. Masao Kawada reported that Mr. Teranishi, Personnel Director, has requested him to make an outline for the Employees' Training Program and would like to consult with the Leaders before submitting. The projector and slide films will be used in the Employees Training Program.

Educational Director reported that Mrs. Francis came to see him for information on attendance at the Co-op Nite Programs which was held recently in each Ward. She also requested that the attendance sheets be filled out for any future gathering.

Mr. K. Hayashi reported that new Co-op Fish Market opened for business yesterday July 8, 1943. At the present, there are five male employees and no manager, but Mr. Shigeo Takeda is acting as an advisor.

Educational Director's reports:

1. Meeting was held on July 7 at 717-A from 8 p.m. to discuss Co-operative Group Farming for the benefit of colonists who intend to resettle. Those present at this meeting were: Messrs. G. Takemoto, K. Kato, H. Sato, T. Ishino, Harry Makino, Frank Tsuda, George Sakoda, Jiro Goto, Masao Kawada, Mrs. Yamada, Mrs. Van Buskirk, teacher at Tri-State High School, and Dr. Opler, analyst for the Tule Lake WRA.

Mrs. Van Buskirk outlined a plan by which a Farm Co-op could be established with about three caucasian and three Japanese families on equal basis. A Credit Union is to be used as a means of raising necessary funds for the initial start on a poultry venture to obtain necessary materials and supplies. Another meeting will be held on July 16 from 8 p.m. at Co-op Central Office 717-A to discuss further on the Co-op Farm resettlement plans.

2. Prizes for the School Co-op Essay Contest winners were presented to Mr. Gunderson, Principal of Tri-State High School, for distribution to the student winners on July 8, 1943.

3. The meetings planned and scheduled by the Adult Education Department on pre-relocation problems were presented to the Leaders for their co-operation in getting the news to the colonists. Mrs. Francis' plan for forming a Resettlement Committee was also reported.

The Leaders stated that more publicity should be given to the meetings-- English and Japanese translations in the Dispatch and the use of posters.

Mr. K. Hayashi reports that Mr. Gunderson has contacted the Tule Lake Bank of America in regard to the forming of a savings club among the students.

Had already been in all blocks

The bank is very willing and in favor of such a plan and will furnish materials necessary to start the savings Club.

To supplement the above report, Mr. MacNeil stated that he has written to the California Credit Union League at Oakland, California. Mr. C. E. Murphy, Executive Secretary, answered as follows:

"It has been my belief for some time that the place to start educating people along credit union lines is before they graduate from school, therefore, your plan seemed to have considerable merit.

"I agree with you that the use of regular bank deposit books might tend to defeat the purpose for which the thrift club is organized and that the organization of a full-fledged credit union might never develop.


"We are forwarding you, under separate cover, a file of informative literature on the subject of credit unions as well as our regular pass book and in addition, we are enclosing a sample of a temporary or mailing type of pass book which is very inexpensive and which might be used in place of the regular pass book. We are enclosing samples of the various bookkeeping forms used by credit unions and a separate price list of these forms."

The Ward Leaders will study the matter further and make recommendations accordingly to Mr. Gunderson.

Mr. MacNeil also made an urgent request to the Leaders to contact interested persons for various offers of employment made by Western Cooperative concerns. He fears that if no applicants for the jobs are found, the opportunity to enter Co-operative Wholesales may be closed to the people in this project and offered elsewhere.

As there were no further business, the meeting adjourned at 11:10 a.m.




Mr. Hashida, Editor of the Cooperator, requested that







A. should aid or give assurance to those persons relocating to obtain loans provided necessity occurs and that such persons by investment in whatever undertaking he establishes shows that his needs are necessary for the successful operation of such business or enterprise. Such provisions are not for the purpose of obtaining unnecessary funds, ^{but} when need occurs. Considerable discussion took place in regard to the above before any conclusions were made.

A short discussion took place on cooperative group farming.



The Educational Leaders had a short discussion on the topic presented by Mr. MacNeil in which he stated that the WRA is considering the matter of retaining persons occupying the important positions until the segregation is completed. The recommendation of the Leaders to the Board of Directors is as follows:


Prepare a list of names of persons occupying key positions in the Co-op, who are willing to stay until segregation is completed, and to submit such list to Mr. Best, Project Director for approval, and that provisions be made to the effect that special consideration or recommendation be given to these persons for employment at the project to which they are removed.

It was decided that the Leaders bring any questions that the colonists wished answered to the Co-op office and transmit them to the Tulean Dispatch or to Mr. Harkness or to any proper person who will publish the answer in the Tulean Dispatch.

It was also suggested that Leaders recommend to the Board of Directors to have any questions the colonists wish to ask about the Co-op business answered by the approval of the proper person depending upon the question and published in the "Co-operator."

As there were no further business, the meeting was adjourned at 11:15 a.m.

The Leaders recommended Mr. F. Hayashi as a possible candidate for the position of Educational Director to be left open after segregation.


After a short discussion, the Leaders thought it would be advisable to have anyone who requests answers on Co-op business to have them ready to be presented at the General Assembly on August 20 and that Leaders to advise them to that effect instead of attempting to answer themselves.

There were several questions brought out by the Leaders in regard to segregation which they were in doubt; however, instead of discussing further it was agreed that some of these questions ought to be taken up at the information centers to save time as well as get more accurate information. Few of the questions were as follows: 1. Do you furnish lumber to make boxes besides crating of household goods? 2. Is it possible to reserve their barrack room to friends because they wish to leave some things that are part of their room for them because, heretofore, after the rooms were vacated many things have been taken.

Letter from Professor Dickinson, Department of Economics, University of Michigan, was passed along to the Leaders for reading. The subject matter of the letter dealt on the Sunrise Farm Community in Alicia, Michigan. It appears that the farm was closed in 1935 and is now in the hands of Farm Credit Administration. It comprises some 8,500 acres with about 80 buildings. It was thought that this property may be available for evacuee group farming project. At the present correspondence is still being carried on to determine how it would be possible to obtain the farm from the Farm Credit Administration.

Since there were no further business, the meeting adjourned at 11 a.m.

Minutes of the previous meeting held on August 18 were approved as presented.




Announcements of Ward Assembly for August 28 and also group farm-meeting at Mess 5320 Friday evening were made.
