I believe I would be safe in saying that their feelings were the same as the majority of Americans, Indignation, at over

such an unwarranted attack when representatives of the Japanese Government were in Washington for interviews and additional time to work out some way of preserving peace between the two Nations.

Also, I believe, I would be expressing the opinion of our City Council in saying that the Federal Government should dictate the measures to be taken to control the movements of the Japanese. Our City Council, of course, would cooperate in helping them to enforce any measures that they might deem necessary for the safety of our Country."
