

Sutro, Adolph Heinrich Joseph, 1830-1898

Papers, 1853-1900. 34 boxes, including 69 volumes.

Adolph Sutro was born in Aix-la-Chapelle, Prussia on April 29, 1830, the third child of Rosa Warendorf and Emanuel Sutro. A successful cloth manufacturer, Emanuel Sutro, died in 1848, leaving the business under the management of Adolph and another son, Sali. The 1848 Prussian Revolution ruined the business, and in 1850 the Sutro family emigrated to the United States. Attracted by talk of the gold discovery in California, and desirous of making his fortune, Sutro set sail for the gold mines shortly after the family arrived in the United States. He arrived in San Francisco November 1850.

Sutro established himself as a merchant in San Francisco and Stockton, at first engaging in the commission business, and later, in the retail sale of tobacco and cigars. In 1856, he married Leah Harris, with whom he had six children.

In 1860, the bonanza strikes in the Comstock Lode drew Sutro to the Nevada mining region. He established a quartz reducing mill in Dayton, Nevada utilizing a process he invented in partnership with John Fandohr. The mill earned Sutro substantial profits and provided the foundation for the financing of his next venture, the Sutro tunnel.

The Sutro tunnel, a major engineering feat, was conceived of and planned by Sutro for the purpose of ventilating and draining the mines. The tunnel was four miles long, beginning at the Carson River, through the heart of Mt. Davidson, to the Comstock Lode. Work began on the tunnel in 1869, and took ten years to complete. Throughout most of this time Sutro was engaged in a continual struggle with the "Bank Ring", the "Irish Four", and the mine owners, who did everything they could to obstruct the completion of the tunnel.

Shortly after the tunnel was completed in 1879, Sutro sold his interest in the Sutro Tunnel Company and returned to live in San Francisco. He invested his profits in real estate, and at one time owned land in San Mateo, Alameda, Napa, Sonoma and Lake counties, and one twelfth of the land in San Francisco. In the 1880s, Sutro's most notable purchase was the land on which the Cliff House was located and the surrounding 1000 acres, known as Sutro Heights. He established his home on the Heights, beautified the grounds, and later opened them to the public. In 1892, he began the construction of the Sutro Baths, near the Cliff House. The Baths soon became a showpiece of magnificent proportions, as did the so-called "third" Cliff House, which Sutro built in 1897.

In 1893, Sutro began another major battle of his life;

this one with Collis P. Huntington and the Big Four of the Southern Pacific Railroad. Sutro opposed the Pacific Railroad Funding bill proposed by Huntington to delay payment of the railroad's debt to the Federal government. In addition, Sutro and the railroad came into conflict over the fare charged by the Market Street Railway, a subsidiary of the Southern Pacific, to the amusement area Sutro had established near the beach. This area comprised the Sutro Baths, Cliff House, and the park on the grounds of Sutro Heights. To combat the railroad's monopoly, Sutro built his own street railway, the Sutro Electric Railway.

Sutro was elected mayor of San Francisco on the Populist Party ticket in 1894. He served one term (1894-96), and this time he was in constant disagreement with the Board of Supervisors over the management of the city, especially regarding issues that affected his personal interests such as street railways and street improvements.

The collection documents Sutro's early career in San Francisco as a tobacco merchant, the financing and construction of the Sutro Tunnel, Nevada politics (1866-1879), including his campaigns for U.S. Senator from Nevada, his fight against Huntington and the Pacific Railroad Funding bill, his term as mayor, land transactions and other business affairs. There are a few letters and notes from Sutro scattered throughout the collection. Unfortunately, they do not for the most part relate to the significant aspects of the collection. There is also some miscellaneous personal correspondence from his brothers and his wife, Leah.

The letters in the collection are incoming correspondence and cover the years 1853-1899. The majority of them concern the Sutro Tunnel and the Pacific Railroad Funding bill. The letters dealing with the Sutro Tunnel include letters from his brother, Theodore, who handled legal matters for the Sutro Tunnel Company; Elliott J. Moore, president of the tunnel company; Pelham W. Ames and W. K. Van Alen, secretaries of the tunnel company; James H. Riley, Washington correspondent for the Alta California, who reported to Sutro on Congressional activities; R. W. Raymond, president of the Engineering and Mining Journal and later U. S. Commissioner of Mines; George T. Coulter, who played an instrumental role in securing financial backing in London for the tunnel; and James J. Robbins; as well as reports from tunnel employees.

Letters regarding the Pacific Railroad Funding bill are primarily from Charles A. Sumner, former Democratic Congressman from California and journalist; F[rederick] B[eecher] Perkins; and J. M. Bassett, former secretary to Leland Stanford. These letters are primarily reports to Sutro on Congressional acti-

vities. The letters from Sumner cover a 26-year period (1872-98) and document his relationship with Sutro. The bulk of these letters, however, deal with the funding bill.

The collection consists primarily of scrapbooks (66 volumes) of newspaper clippings for the years 1866-1898, covering the major interests of Sutro's business and political career.

There are twenty-five (25) volumes covering the period Sutro was involved in constructing the Sutro tunnel (1866-79). Included in these volumes are clippings regarding the Nevada silver mines, mining stocks, and Nevada politics. In these volumes there are several clippings from the Sutro Independent, a newspaper published by Sutro in the town he founded, Sutro, Nevada. Fourteen (14) volumes document Sutro's battle with the Southern Pacific Railroad (1893-97). Seventeen (17) deal with political events and issues in San Francisco during the years Sutro served as mayor, (1893-97). Covered in these volumes are actions taken by the Board of Supervisors, water rates, street railroads, and street improvements. The remaining seven volumes contain clippings covering a variety of topics, including politics and business, but mainly on San Francisco's social life.

The collection also includes deeds, contracts and leases for landholdings and other property; 3 check-receipt books (1890-93) and receipts and bills for services and purchases made for Sutro Heights, Sutro Baths, and Sutro's other property; and other documents and miscellaneous papers.
